### SPECIAL BUSINESS:

1. To pass with or without modification the following resolution as a Special Resolution:

"**RESOLVED THAT** pursuant to the provisions of sections 196(3) (a) and other applicable provisions, if any, of the Companies Act, 2013 (including any statutory modifications or re-enactment thereof for the time being in force) and Articles of Association of the Company, approval of members be and is hereby accorded to appoint Brig SCK Puri (DIN: 08469887) as a Whole Time Director of the Company, be and is hereby appointed as a Whole Time Director of the Company for a further period of 5 (five) years w.e.f. 1<sup>st</sup> July, 2019 to 30<sup>th</sup> June, 2024 on the following terms & conditions with discretion to the Board of Directors of the Company to grant such additional /annual increments and other benefits/ perguisites and alter the terms as the Board may think fit:

- 1. Basic Salary: Rs. 2,22,000/- per month.
- 2. Benefits, Perquisites And Allowances :
  - (a) Housing: He will be provided by the Company unfurnished accommodation and 15% of the remuneration shall be deducted by the Company from his salary. In case no housing is provided by the Company, House Rent Allowance shall be paid as per rules of the Company.
  - (b) **Special Allowance**: 20% of per month Basic Salary.

  - (b) The Whole Time Director shall be entitled to leave in accordance with the Rules of the Company. Privilege Leave earned but not availed by the Whole Time Director can be encashed upto maximum 120 days.

- 4. The valuation of perquisites shall be in accordance with the applicable provisions of the Income Tax Act, 1961 read with Income Tax Rules, 1962.
